At the last Board of Directors meeting, the SSCCC recently took a stance in support of Proposition 16, which would remove the ban on Affirmative Action in the California Constitution. Please see the Press Release below for more information.

What is Affirmative Action?

Affirmative action is a set of laws, policies, guidelines, and administrative practices "intended to end and correct the effects of a specific form of discrimination" that include government-mandated, government-approved and voluntary private programs.



Propositions 17 and 18

Support for Proposition 17

Currently California is 1 of 3 states which disqualifies convicted felons from voting until their imprisonment and parole are completed. This ballot measure would allow felons who are on parole to vote. As of 2020, 19 states allowed people convicted of felonies who were on parole the right to vote. Additionally, a survey conducted by a pro-voting rights group last year estimated the ban on parolees voting impacts about 40,000 Californians; two thirds of which directly affected community college students. The passage of Proposition 17 would restore voting rights to disqualified electors and ensure that all voices are heard in the electoral process._

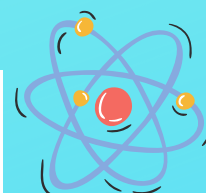
Support for Proposition 18

This ballot measure would allow students who will be 18 by the next general election to vote at age 17 in the primary elections. As of 2020, 18 states and the District of Columbia allow 17-year-olds who will be 18 by time of the general election to vote in state primaries. Additionally, 57% of high school students enroll in a California community college and many other students are dual enrolled in a community college. The passage of Proposition 18 would complement the civic education highschoolers receive and foster early involvement in the electoral process.

ICE Guidelines (Coronavirus FAQ)

Coronavirus

Middle East respiratory syndrome (MERS) and severe acute respiratory syndrome (SARS) are viral respiratory illnesses caused by a coronavirus.

Severe symptoms

- High fever (100.4°F or higher)
- Pneumonia
- Kidney failure

Transmission

Coughs or sneezes from infected person or touching contaminated objects.

Common symptoms

Fever

A dry cough develops after 2 to 7 days
